**DVD Rental Agreement - Theater**

**The Parties**

LLT Productions, Inc. (LLT), a California Non Profit Corporation (**Owner**), hereby grants to \_\_\_\_\_ (**Lessee**) the use of a DVD, BluRay, or DCP (digital cinema package) version of the film "Hell & Mr. Fudge" for screening at Lessee's rented theater as described below, subject to the following **terms and conditions**:

1. This agreement allows multiple screenings of the movie in a rented theater on the dates listed on the "Date(s) and time(s) of screening(s)" line below. No additional private or public screening, in whole or in part, is permitted without prior authorization from Owner.
2. Theater rental will be negotiated between Lessee and theater, and Lessee will be responsible for payment of the theater rental fee.
3. Owner will provide to theater management, on request, written authorization for screening the film.
4. Proceeds (if any) from ticket sales/admission may be applied to theater costs, film rental, etc., and any net proceeds will be retained by Lessee.
5. Lessee bears exclusive responsibility for the security of the film and will prevent copying or photographing of the film.
6. All fees and deposits are in US dollars and must be paid in advance.
7. This agreement will be governed under the laws of the State of California.
